Old Business:

The Oscoda County Economic Development Corporation (EDC) falls under Michigan Public Meetings Act (PMA) #338 of 1974 requiring EDC boards to have at least nine members. The EDC Board meetings will continue the second Wednesday of each month, unless otherwise noted/posted; however, will not be making financial decisions until the headcount requirement of the PMA #338 is met. The current EDC Board members will be responsible for reviewing the status of loans and loan documents. Once the requirements of PMA #338 are met the EDC Board will be required to file the original Articles of Incorporation with the Oscoda County Clerk's Office and to the State of Michigan.

Cy Wakely suggested the EDC Board should conduct and interview process at its February 7, 2018 meeting and set a deadline of January 31, 2018. The board agrees it will conduct a brief interview process with each candidate in which Letters of Intent have been received from Kyle Yoder, Misty deGuzman, and Dawn Harwood and any others prior to January 31, 2018 for consideration to join the EDC Board.

Revolving Loan Fund documents are to be provided to each board member from Cy & Jessica Wakely on a monthly basis for review by the EDC Board.
