## Official Minutes

January 12, 2016

A Regular Meeting of the Oscoda County Board of Commissioner's was held on Tuesday, January 12, 2016, at 10:00 a.m., in the Commissioner's Room, Courthouse Annex Mio Michigan

Members Present: Commissioners Kischnick, Christenbery, Wilson, and Boerner.

Members Excused: Grantner.

Others Present: 8 members of the public were in attendance.

The County Clerk & Register of Deeds, Ms. Jeri Winton, called the meeting to order at 10:00 a.m. Roll Call, followed by the Pledge to the Flag
