<u>Item #1</u> Official Minutes for <u>December 14, 2021,</u> were approved as amended. Motion 2021-369 was corrected to indicate that the EMS invoices from Motor Pool needed a journal entry only and were not paid out of the Claims & Audit; the official minutes have been corrected.

<u>Item #2</u> Building Department 2021 Rent; the annual request from Tim Whiting, Building Inspector, to authorize the Treasurer's Office to transfer the Building Departments rent to the General Fund, were approved.

\*\*County Treasurer, Bill Kendall, informed the B.O.C that he has entered into an agreement with MSHDA, through the Treasurer's Office, for MIHAF (Michigan Homeowners Assistant Fund) that will assist homeowners, who are quantify, with homeowner mortgage delinquencies, defaults, foreclosure, etc.

## **Appointments:**

\*\*Mr. Brian Harrison, Executive Director of Therapy Services AdvisaCare, Home Health & Hospice, presented information on the Michigan No-Fault Auto Insurance Reform Act of 2019. Oscoda County B.O.C was asked to adopt a resolution that would urge the Michigan Legislature to amend the Michigan No-Fault Auto Insurance Reform Act to address a sustainable reimbursement cap based on an existing Government payor (Medicaid, Veterans Affairs, etc.) for residential care facilities, and home health providers who provide necessary care to auto accident victims in order to uphold these benefits that have been paid for by the survivors who currently are receiving and who will receive long-term care when purchasing an Unlimited PIP Auto Insurance policy paid by the Michigan Catastrophic Claims Association; it was the consensus of the B.O.C to adopt in support.

McCauley/Bondar a motion to adopt Resolution 2021-013 "Urging State Legislature to Amend the
 2021-374 Michigan Auto Insurance Reform Act to Address a Reimbursement Cap for Auto Accident Victims", as written.
