2.) Mr. Greyling Brandt, District Ranger – United States Department of Agriculture

Mr. Greyling Brandt, District discussed information pertaining to the Secure Rural Schools (SRS) Title II funding that is allocated to Oscoda and Wexford Counties.

The current annual break down of Secure Rural Schools base funding of \$279,199.90 for Oscoda County is as follows:

- <u>Title I: 80% or \$223,359.92</u>, paid directly to the County for public schools and public roads. State of MI splits this dollar amount in to 75% for school and 25% for roads.
- <u>Title II: 13% or \$36,295.99</u>, held by the Forest Service and allocated by a Resource Advisory Committee. Money can be spent on any National Forest Lands or Adjacent Lands in the state.
- <u>Title III: 7% or \$19,543.99</u>, paid directly to the County and can be used for emergency services and broadband installation and expansion.

Mr. Greyling Brandt offered to donate fire rings, tables, etc. to the Oscoda County Park from the Forest Service.
